Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 5:00pm Australian Eastern Daylight Time (AEDT) **on** 22/03/2024.

**How to lodge nominations**, nominations must be lodged via the following method:

**The subject line for the email should read: “E2023/203 – ASMOF Nomination - [Your name]”.**

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

## Withdrawing Nominations

Nominations may be withdrawn up until the close of nominations at 5:00pm Australian Eastern Daylight Time (AEDT) **on** 22/03/2024.

## Candidate Statements

Candidates may submit a statement to be included with ballot material. As per rule 76(10)(c)(ii) ‘a candidate statement **must not exceed 200 words** and will include a biography and/or statement in support of their candidature, together with a photograph of the candidate if desired.’

Only statements which comply with the Rules and are received by the Returning Officer by 5.00pm (Australian Eastern Daylight Time (AEDT)) on 22/03/2024 can be accepted.

## Voting Period

The ballot, if required, will open on 12/04/2024 and close at 5:00pm Australian Eastern Daylight Time (AEDT) on 10/05/2024.

## Scrutineers

The appointment of scrutineers opens 01/03/2024.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
